- provided all required working conditions are met, energy savings for industrial, stationary equipment may reach an up to 11% level. The study was conducted comparing result data in working conditions: Husky XL300, Krauss Maffei KM 80 CX SP 380, Engel Victory 330/120, Boy 35 E, Haitian MA10000 II
